Truth in Taxation

**1) The meeting was called to order** by Mayor Bob Dablow at 7:32PM.

a) Council Members present were Bob Dablow, Tom Berglind, Lloyd Helgeson, Adam Jenstead and Drew Schwan.

b) Others Present were Wendy Otte/Clerk, Doug Smith and Mike Kurkowski.

**2) The motion at the December 3<sup>rd</sup> budget meeting raising garbage rates needs to be amended** due to a rate increase by Fuch's Sanitation. The original motion raised resident garbage rates from \$17.66 per month to \$18.10 per month and increased all other garbage rates 4%, beginning with the January 2020 billing. To adjust for the increase by Fuch's Sanitation the rates will be increased from \$17.66 per month to \$18.50 per month for residents and by 7.8% for all other garbage rates.

**A MOTION** was made by Tom Berglind to raise resident garbage rates from \$17.66 per month to \$18.50 per month and increase all other garbage rates 7.8% per month, beginning with the January 2020 billing. It was 2<sup>nd</sup> by Drew Schwan and the motion carried.

#### **a) Recycling**

#### **d) Waste-Water**

**A MOTION** was made by Adam Jenstead to approve the 2020 Waste-water Budget. It was 2<sup>nd</sup> by Lloyd Helgeson and the motion carried.

#### **e) Water**

**A MOTION** was made by Lloyd Helgeson to approve the 2020 Water Budget. It was 2<sup>nd</sup> by Drew Schwan and the motion carried.

#### **f) General Expenses**

**A MOTION** was made by Tom Berglind to approve the 2020 General Expenses Budget. It was 2<sup>nd</sup> by Adam Jenstead and the motion carried.

#### **g) General Receipts**

**A MOTION** was made by Drew Schwan to approve the 2020 General Receipts Budget. It was 2<sup>nd</sup> by Lloyd Helgeson and the motion carried.

### **4) Property Tax Levy**

**A MOTION** was made by Tom Berglind to adopt a resolution setting the 2020 general levy at \$153,000.00 and the special levy at \$39,297.00, which is the same as last years tax levy with no tax increase for 2020. It was 2<sup>nd</sup> by Adam Jenstead and the motion carried.
